SCHOOLCRAFT COUNTY BOARD OF COMMISSIONERS PERSONNEL COMMITTEE MEETING

The Schoolcraft County Board of Commissioners Personnel Committee met on Friday, January 19, 2024, in the 1st Floor Conference Room, of the Schoolcraft County Building, City of Manistique, Michigan, commencing at 10:03 a.m. The meeting was called to order and roll was taken:

Present: Commissioner Troy Bassett

Commissioner Craig Reiter (acting member for Commissioner Daniel P. Hoholik)

Beth A. Edwards, Clerk

Commissioner Troy Bassett led the committee in the Pledge of Allegiance.

Discussion:

Judge Beth A. Gibson addressed the starting wage of the Supervisor/Magistrate Position. Would be asking the Board for an exemption of 10% reduction in wage from the prior Magistrate pursuant to Policy and Procedure. Further stated that while this position has been vacant the County has realized a savings of around \$85,000.

Commissioner Craig Reiter addressed the Policy and Procedures and feels that the reduction needs to be followed, although Mr. Shiner is educated there is no comparable work experience in this field of work. Judge Gibson also addressed the policy provides for exception to the reduction based on education and or prior work experience in a previous comparable position.

Commissioner Reiter expressed his thought as setting the salary based on the \$50,710.90 (Current Magistrate Salary if not vacant) minus 10% which would be \$45,639.81 following the 10% reduction in the Policy and Procedures.

Commissioner Troy Bassett asked about a look at an increase at any time or just at this point. The policy says the 10% can be waived and reviewed in 91 Days for a 5% increase. Can an increase be reviewed at any time or only now. It was discussed that a review can be requested at any time.

Judge Gibson addressed the Magistrate training is in March. Mr. Smith, new Magistrate in Alger County, and Mr. Shiner will be traveling together, which will save a little bit of money. Judge Gibson also addressed the bonding of the new employee.

There was further discussion regarding the position, starting duties, and appointment as supervisor/magistrate.

RECOMMENDATION of Personnel Committee to move this to Audit/Finance Committee for finance review and the full board to approve paying John Shiner (as hired by Judge Beth A. Gibson) as a supervisor starting January 22, 2024, at a rate of \$45,639.81 annually (10% Reduction) from the Supervisor Line Item until the request for appointment as Magistrate is made and approval by the County Board. After appointment as Magistrate,

training, and the 91-day probation period is completed, Judge Gibson can request a review for a 5% increase of the original salary of \$50,710.90.
