Chairman Paul Walker led the Schoolcraft County Board of Commissioners and the members of

It was moved by Commissioner Troy Bassett and was seconded by Commissioner Craig Reiter to approve the minutes of the April 13, 2023, Board and Audit-Finance Meeting of the Schoolcraft

Don Erickson and Eric Sherbinow, UP Film Union, (Non-Profit 501c) presented a request for ARPA Funds in the amount of \$15,000 to support the free entrance movies and events at Highway 2 Drive-In. It was moved by Commissioner Craig Reiter and was seconded by Commissioner bb to move the request to the Audit-Finance Committee for review. The motion carried by unanimous aye vote of the Board members present.

It was moved by Commissioner Troy Bassett and was seconded by Commissioner bb to appoint Barbara Boyer to the Schoolcraft County Jury Board (six-year term - April 30, 2029). The motion carried by unanimous aye vote of the Board members present.

It was moved by Commissioner Paul Walker and was seconded by Commissioner Troy Bassett to authorize Paul Walker, Board Chair, to sign the Corrective Action Plan and submit the plan to the Michigan Department of Treasury. The motion carried by unanimous aye vote of the Board members present.

It was moved by Commissioner Craig Reiter and was seconded by Commissioner Paul Walker to authorize Paul Walker, Board Chair, to sign the Letter of Understanding from AFSCME and FOPLC Unions regarding the 5% raise for May 1, 2023. There was a discussion. Roll call vote: Craig Reiter, yes; Paul Walker, yes; Bruce Birr, yes; Troy Bassett, no; Daniel Hoholik, yes. The motion carried by majority aye vote of the Board members present.

It was moved by Commissioner Craig Reiter and was seconded by Commissioner Paul Walker to approve the LMAS Lease (650 square feet of additional office space) and authorize Paul Walker, Board Chair to sign the lease agreement effective May 1, 2023. The motion carried by unanimous aye vote of the Board members present.

It was moved by Commissioner Troy Bassett and was seconded by Commissioner Paul Walker to approve and authorize Paul Walker, Board Chair, to sign the Letter of Understanding with MDOC for a Brother MFC-L5700DW printer/scanner/copier/fax, maintenance, and supplies. The motion carried by a unanimous aye vote of the Board members present.

It was moved by Commissioner Craig Reiter and was seconded by Commissioner Troy Bassett to approve a letter of support for the Manistique Pistol and Rifle Club to receive a grant for an AED Defibrillator Unit. The motion carried by unanimous aye vote of the Board members present.

Sheriff Charles Willour stated that both vehicles have been sold, still waiting on Fire Marshall approval for the back door project at the jail and would like to have further discussion on another patrol car.

Corey Barr addressed the Cruise Ships this summer, Ambulance Plan, Planning Commission-City Master Plan, Blight Elimination Grant for Schoolcraft Memorial Hospital in the amount of \$200,000.

Erin Daines, MSU District 2 Director, addressed the contract with Limestone Federal Credit Union for a Youth Entrepreneur Program, SNAP Ed program, and Governance Board.

# SCHOOLCRAFT COUNTY BOARD OF COMMISSIONERS PERSONNEL COMMITTEE MEETING

The Schoolcraft County Board of Commissioners Personnel Committee met on Tuesday, May 2, 2023, in the 1st Floor Conference Room, of the Schoolcraft County Building, City of Manistique, Michigan, commencing at 8:55 a.m. The meeting was called to order and roll was taken:

Commissioner Craig Reiter led the committee in the Pledge of Allegiance.

Additions: Microphones in the Courtrooms, Automatic Deposit of Payroll Checks, Opioid Funds, Wage Increase other than Percent Based and Dog Policy

#### Discussion:

Beth E. will contact Dan Edwards with regards to the microphones in the Courtroom and the computer that needs set up in Probate Court.

Dog Policy Update - Tim Noble has the written policy provided by Commissioner Craig Reiter. He has reviewed the policy and will be making slight revisions. It will be distributed after revision and put on the next agenda.

Personnel Policies and Procedures Review (pages 26-30) – As discussed – Longevity Payments have not been updated since the Union received an increase two years ago.

RECOMMENDATION to move longevity increase to the Audit-Finance Committee for review. The change would not affect the current year's budget as Longevity Pay gets paid in late November or early December.

Next meeting there will be a review of the next 5 pages of the Personnel Policy.

Direct Deposit for Payroll Checks were discussed. Approximately 10-12 checks are cut and the remainder are direct deposits at this time. As a cost saving and time saving measure – **RECOMMENDATION** to make all payroll checks direct deposit as of July 1, 2023, and move this to the full board for discussion and approval.

Commissioner Craig Reiter addressed SUD/Northcare and the Opioid Settlement Funds that are received by the County. These funds can be managed by the Sheriff, Clerk, or Northcare. Craig Reiter advocated to send the funds to Northcare and let them manage the money and reports. They will do this service for free. A plan needs to be developed to create programs for opioid abuse either in schools and/or the jail. RECOMMENDATION for work group (Commissioners, Sheriff, School, SMH) to be set up to determine what programs are already implemented or in the works, what is needed, and who can utilize a program.

Commissioner Craig Reiter addressed the issue of percent raises and wage gapping. A suggestion is to add all salaried Elected/Department Head waged together multiply by the percent increase, and then divide by the number of individuals receiving the increase. This would give an equal wage increase to all salaried employees. There was discussion regarding fairness and rate of pay for the position. There was favorable and unfavorable points to this way of figuring a raise as there is for the percentage to each salary. No action taken.

Steve V. again addressed his salary versus his stipend for other duties and not receiving the 5% on those stipends only on the salary. There was a discussion. RECOMMENDATION to move to Audit-Finance Committee to increase the stipends paid to Steve Videtich for extra duties by 5% and then roll all the stipends into his wage and have one salary for the duties he performs.
